#### Privacy Policy

#### Introduction

Ohio River Trail Council (ORTC) respects each individual's right to personal privacy. We will collect and use information through our web site or through email correspondence only in the ways disclosed in this statement. This statement applies to information collected at [www.ohiorivertrail.org](http://www.ohiorivertrail.org).

#### Part I. Information Collection

As a registered member of the Ohio River Trail Council website, the Council collects general information and demographic data that may be personally identifiable information. This information includes name, title, company name, address, telephone number or e-mail address that you voluntarily provide through [www.ohiorivertrail.org](http://www.ohiorivertrail.org) or e-mail correspondence. We may collect this information through registration forms and automatic logging files, and so on.

We do employ cookies. A cookie is a small text file that a web server places on a user's computer hard drive to be a unique identifier. A session cookie is used to enable the bread crumb trail, and it is discarded when your browser closes. Our content management system employs cookies to facilitate the information that is presented to you. No other use is made of cookies.

As you browse the [ohiorivertrail.org](http://ohiorivertrail.org) website a log file is kept containing the IP number of your connection, and the pages that you visit. This information is used to enable us improve the website. To see what pages are frequently visited, which are not accessed and how individuals use the site. No attempt is or will be made to associate the IP address with an individual.

#### Part II. Sharing and Information Usage.

The information collected by the Ohio River Trail Council will be used to communicate with our readership and membership. Registered members will receive additional announcements from us about membership meetings, trail updates and a newsletter. Out of respect for the privacy of our users, we present the option to not receive these types of communications.

The information we collect will not be used to create customer profiles based on browsing, donations or purchasing history. We will not supplement information collected at our web site with data from other sources, such as credit history to authorize donations or purchases. We may share data with third parties such as shipping carriers and credit card companies.

Our Web site offers chats, forums or message boards. Please be advised that information posted in these venues becomes public knowledge.

If our policy on information collection or uses changes, we will advise you by email within thirty days.
