Recent Successes

Delaware River Water Trail

In 2010, RTCA guided a Steering Committee consisting of staff from the Upper Delaware Scenic & Recreational River, Delaware Water Gap National Recreation Area, Delaware & Lehigh National Heritage Corridor, Pennsylvania Fish and Boat Commission, New Jersey Department of Environmental Protection (NJ DEP), and American Canoe Association's Delaware Valley Division in the development of a comprehensive signage program for paddlers on the 220-mile water trail through the three states of New York, Pennsylvania, and New Jersey. The signage program was based on the previously established Delaware River Water Trail Concept Plan.

A \$26,270 NPS Challenge Cost Share grant funded the development of the sign plan, while Pennsylvania Department of Conservation and Natural Resources and NJ DEP funds totaling \$49,000 are contributing to the development of additional plans to improve river safety, and enhance marketing of the water trail, including the creation of an interactive, trip planning web site.

Project Goal

Develop 5 acres of park lands within Derry, and 20 miles of trails linking Derry parks, Chestnut Ridge, and communities of Blairsville and Latrobe in Westmoreland County.

3. Logan Triangle Redevelopment

Location: Inner city neighborhood of Philadelphia; 35 acre plot of vacant blighted land

Create attractive park/green space with walking and bike trails; potentially leading to further site re-development.

Develop 41 miles of bike trail along the Ohio River in PA, from Coraopolis west to Point of Beginning (the PA-WV-OH state line), as part of a vision for a linking system of over 100 miles of land & water trails in PA-OH-WV.

Recent Successes cont.

Schuylkill River to Boar's Back Trail and Hopewell Big Woods

In 2009 RTCA, working with the Natural Lands Trust and a consortium of more than 40 federal, state, and local agencies and organizations, completed an action plan for a trails system through the Hopewell Big Woods, the last large, unbroken forest in southeastern Pennsylvania. The Hopewell Big Woods Trails and Recreation Concept Plan proposed more than 50 miles of trails that would support heritage tourism and utilize the area's outstanding cultural history and recreational and natural assets. These assets include Hopewell Furnace National Historic Site and French Creek State Park, alone totaling more than 9,000 acres of protected forest and greenspace.

In 2010, 8 out of the 12 municipalities that are part of the Hopewell Big Woods passed resolutions supporting the plan. Outgrowths of the plan include: the addition of three properties totaling 279 acres to French Creek State Park to provide critical connections to the Schuylkill River Trail and Schuylkill River National & State Heritage Area, Hopewell Furnace NHS, and Pottstown Borough; the development of a regional conservation and heritage tourism strategy for the lower Schuylkill River corridor from Reading to Valley Forge; and the design and completion of more than five miles of trails within the Hopewell Big Woods. In FY11, RTCA is assisting the design of a multi-use trail connection from the Schuylkill River Trail to the Boar's Back Trail through the heart of French Creek State Park, with connections to Hopewell Furnace, the historic village of St. Peters, and other key destinations.
