GENERAL: The Ohio River Trail Council (ORTC) is committed to make this year's Gear and Cheer Music Festival a great success. We can typically expect a lovely day with mild winds and warm temperatures.

DATE & LOCATION: **July 19, 2015.** The festival is a combined indoor and outdoor event located at and near the Lodge at Bradys Run Park - Beaver County, PA. [Bradys Run Park Map](#) [The Lodge at Bradys Run Park \(Google Map\)](#). GPS: 40.731316,-80.351837



PARTICIPATION: Alcohol Vendors are located inside the Bradys Run Park Lodge. Selection is based on a first-come first- served basis using the date of registration; therefore please submit your application at your earliest opportunity. All locations within the lodge are excellent and are handicapped accessible, therefore specific spaces are not guaranteed. The location of Vendor's Space will be at the sole discretion of the Festival committee.

HOURS OF OPERATION: **Vendor arrival is between 7:00 a.m. and 8:30 a.m. eastern standard time.** Beer & Wine Tasting occurs from 10:00 a.m. to 6 p.m. Vendor parking is reserved near the Bradys Run Park Lodge.

VENDOR FEES/FREE TICKETS: There is no required donation fee to the ORTC for alcohol vendors. The Vendor receives five (5) complimentary tasting tickets (\$100 value) for festival staff. Wine Vendors (Limited Winery Licensee) who also want to sell product may need to obtain a wine exposition permit. Alcohol vendors can sell any product as long as it meets Pennsylvania regulations.

VENDOR OBLIGATIONS & EQUIPMENT: The ORTC provides tasting glasses, tables, chairs, ice and electricity. Vendors will be required to provide all equipment to be used for display, sales and the preparation and serving of drink items, including refrigeration if necessary. All Vendors shall be responsible for cleaning their space during and after the event. All garbage must be disposed in the trashcans provided or in the dumpster behind the lodge. Please contact the ORTC if you need assistance with any of the above.

LIABILITY & LICENSES: Vendor assumes all responsibility for a) loss, personal injury and/or liability for any damage to its property or merchandise; and b) any sickness or illness caused from the food and/or drink served from its concession. The ORTC is to be held harmless for any liability or loss caused by theft, damage, destruction, injuries or negligence. Vendor expressly agrees to indemnify, protect and hold harmless the Promoter; its officers, directors, principals, executive committee members, festival sponsors from any liability whatsoever in connection with this event. The Vendor agrees to name the ORTC as an additional insured on the Vendors general liability insurance coverage through a Certificate of Insurance. All licenses and permits to sell foods including the FDA and Department of Agriculture is the sole responsibility of the Vendor.

DISCLAIMER: The festival will be held rain or shine since the Lodge is an indoor facility. The ORTC makes no representation as to the number of potential Festival attendees and assumes no liability for any financial loss.
